

Missouri General Assembly: Glossary of Legislative Terminology

Adjourn: The act of closing business, done by a committee or the House or Senate. See also Sine Die.

Adoption: A preliminary action of the House or Senate or of a committee in considering amendments and substitutes. Amendments are adopted. Committee substitutes are adopted before they are voted do pass by a committee or perfected by the House or Senate. House or Senate substitutes are adopted before they are perfected or third read by the House or Senate. Conference committee reports are adopted before the bill or amendments they recommend are third read. Ordinarily, the final action on a House or Senate resolution is adoption.

Amendment: A modification of a bill or another amendment, offered in committee (a House or Senate committee amendment), on the floor (a House or Senate amendment), or in conference committee

(a conference committee amendment). See also Perfecting Amendment.

Appropriations Bill: A bill to appropriate state and federal funds to the uses of state government. The first 25 House bill numbers are reserved for appropriations bills each session.

Bill: An enactment of the General Assembly which (1) changes the law either by adding new statutes, repealing old statutes, or modifying current statutes, or (2) appropriates public money. A bill introduced in the House is called a House Bill (HB) and a bill introduced in the Senate is called a Senate Bill (SB). Bills are numbered consecutively upon introduction starting with the first regular session and continuing through the second regular session.

Types of session convenings


- Regular Session: When the General Assembly meets to conduct business. The regular session is January through May. The session in odd-numbered years is called the first regular session; that in even- numbered years is called the second regular session.
- Veto Session: A session of the General Assembly to consider overriding vetoes of the Governor. A veto session is held starting on the Wednesday following the second Monday in September.






Types of session convenings

- Extraordinary Session: A session of the General Assembly called by the Governor to consider specific business.
- Special Session: While the umbrella term of "special session" is commonly used to refer to both types of additional assemblies, a true special session is one controlled by the legislature. A session of the General Assembly called by two-thirds of the members of the House and Senate to consider specific business.

Types of bills

- Might have "companion" bills
- Consent bill: A non-controversial bill which does not cost anything to implement and does not reduce revenues. There are limitations to amend a consent bill.

Who files/handles a bill

- Sponsor: The member of the House or Senate who introduce a bill.
- Co-sponsor: When two or more members of the House or Senate jointly introduce a bill.
- Handler: The member of the House or Senate who introduces a bill or is responsible for the bill on the chamber floor.





Title of a bill

- Title: Notice of the subject of the bill.
- Titles of bills have a vote.
- Why does this matter:
 - Amendments must be "germane" to the bill title meaning it relates to the subject matter being considered.
 - Example, "patient consent to examination" to "public health"

 - 24-hour notice
 - Senate/House differences
 - Witness form
 - For
 - Against
 - Informational purposes only





Executive session hearing

- Executive Session: A meeting of a committee to conduct business, usually to vote on bills referred to the committee.
- 24-hour notice (generally)
- Quorum: The number of members required for a body to do business. The rules of each chamber set this number for committees. The state constitution requires a majority of members to be present for the House and the Senate to conduct business.
- Do Pass (Voted or Reported)



When do new laws take effect?

- Unless otherwise specified, effective date for bills passed in a regular session is August 28th.
 - Appropriation bills (state fiscal year is July 1-June 30)
- Exceptions
 - An emergency clause passed (requires an additional vote)
 - Delayed implementation by date or action
 - Veto override
 - Ballot





New law and ongoing advocacy

• RSMo: Abbreviation for Revised Statues of Missouri, the codification of Missouri laws.

29.351. Audit of state auditor's office, when — procedure — cost, how paid. — 1. During the regular legislative session which convenes in an odd-numbered year, the general assembly shall, by concurrent resolution, employ an independent certified public accountant or certified public accounting firm to conduct an audit examination of the accounts, functions, programs, and management of the state auditor's office. The audit examination shall be made in accordance with generally accepted auditing standards, including such reviews and inspections of books, records and other underlying data and documents as are necessary to enable the independent certified public accountant performing the audit to reach an informed opinion on the condition and performance of the accounts, functions, programs, and management of the state auditor's office. Upon completion of the audit, the independent certified public accountant shall make a written report of his findings and conclusions, and shall supply each member of the general assembly, the governor, and the state auditor with a copy of the report. The cost of the audit and report shall be paid out of the joint contingent fund of the general assembly.

2. The commissioner of administration shall bid these services, at the direction of the general assembly, pursuant to state purchasing laws.
